City and County of Honolulu Public Access

The Assessor is required by law to assess all taxable property at 100% of market value. These values are used to calculate and set levy rates for the various taxing districts in the county, and to equitably distribute tax responsibility among taxpayers. The Assessor's office appraises property both by physical inspection and by market activity.

Assessor - Kitsap County, Washington

There are 24 local State assessment offices, one in each county and Baltimore City. Assessments are certified by the Department to local governments where they are converted into property tax bills by applying the appropriate property tax rates. An assessment is based on an appraisal of the fair market value of the property.

Note: A premium land tax marginal rate of 2% applies for special trusts on the total taxable land value above \$4,488,000.
