### WHEREAS FORMAT TEMPLATE

The resolved clauses of a resolution tell the reader what ACTION which should be taken to solve the problem set up in the whereas. The resolved clauses should be the strongest part of your resolution. The first word of the resolved clause should be a verb, and should show what will follow in the clause.

### Resolutions / How To Write A Resolution

Resolutions begin with "Whereas" statements, which provides the basic facts and reasons for the resolution, and conclude with "Resolved" statements which, identifies the specific proposal for the requestor's course of action. Whereas Statements : Background or "Whereas" information provides the rationale for the "resolved" course of action.

### Guidelines for Writing Resolutions | University Senate

A board resolution template is pretty simple. You have to make sure that a specific issue or point that needs a decision is presented to the board so they can address it. A board resolution sample will include places to insert the date, time and location of the meeting. This is found at the top of the page.

Step 1 Put your resolution in writing. Write the reasons for the resolution in a preamble. Start each clause of the preamble with "whereas" with a capital "W." Close each clause with a semicolon or comma followed by "and." Avoid the use of periods.

### **How to Propose a Resolution Under 'Robert's Rules of Order ...**

There are 4 sections to a funeral resolution which includes the title, whereas statements, be it resolved statements and concluding paragraph. The following is an example of a traditional funeral resolution: Church Resolution In Loving Memory of Jane W. Smith No matter what your trials are, or how big your mountain seems;

### **Example of a Funeral Resolution - The Funeral Program Site**

State the responsibility of the board with regard to the resolution subject in the second sentence. This establishes the board's right to take the action. For example, "Whereas, the board is responsible for approving (state action here)" is a possible second sentence.
